

The tenderers shall have to submit EMD of Rs.1000/- (Rupees One Thousand) only in the form of Crossed Demand Draft/ Banker's Cheque drawn in favour of **OMEO KUMAR DAS INSTITUTE OF SOCIAL CHANGE AND DEVELOPMENT** from any Nationalized Bank which is payable at Guwahati. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.
